Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to srbeautystudio.com, and SR Studio, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to SR Studio, LLC include srbeautystudio.com, SR Beauty Studio, SR Photo Studio and SRPhotostudio.com. The SR Beauty Studio website is a photos and ecommerce site. By using the SR Beauty Studio website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, SR Beauty Studio may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase SR Beauty Studio's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us.
